AFLAC	<b>14th calendar day</b> : for the 1st of the month effective date. 15th of the month not available.
ANTHEM BLUE CROSS	<b>5th "working" day</b> : for the 1st of the month effective date. <b>12th calendar day</b> : for the 15th of the month effective date.
BLUE SHIELD OF CALIFORNIA	<b>Last business day</b> : for the 1st of the month effective date for <b>April-January 2021 submissions</b> . HMO plans effective only on 1st of month.
CALCPA HEALTH <sup>1</sup>	<b>5th business day</b> : for the 1st of the month effective date. 15th of the month not available.
CALIFORNIACHOICE®	<b>15th of the month</b> : for the 1st of the month effective date. 15th of the month not available.
CHOICE BUILDER®	<b>Month to month</b> : for the 1st of the month effective date. 15th of the month not available.

GUARDIAN	<b>Groups 2-24</b> : No deadline date for the 1st or 15th of the month effective date. <b>Groups 25<sup>+</sup></b> : 5th business day for the <b>15th of the month</b> .
HEALTH NET	<b>5th calendar day</b> : for the 1st of the month effective date, with the exception of May and October 2020. (due date is: 5/6/20 & 10/7/20. <sup>2</sup> <b>15th of the month effective date</b> must be submitted by the 20th of the month for which coverage is to be effective. Only available for groups in which coverage ends on the 14th with their prior carrier.
KAISER PERMANENTE	<b>5th business day</b> : for the 1st of the month effective date. 15th of the month not available. Kaiser's late enrollment letter form must accompany groups received between the 2nd and 5th business day of the requested effective month.
MEDIEXCEL	<b>5th calendar day</b> : for the 1st of the month effective date. 15th of the month not available.
MET LIFE	<b>5th business day</b> : for the 1st of the month effective date. <b>15th of the month effective date</b> must be received by the 5th business day after the 15th.
OSCAR HEALTH	<b>5th business day</b> : for the 1st of the month effective date. <b>15th of the month effective date</b> must be received by the 5th business day after the 15th.
PREMIER ACCESS	<b>No deadline date</b> : for the 1st or 15th of the month effective date.
PRINCIPAL FINANCIAL	<b>5th business day</b> : for the 1st of the month effective date. <b>15th of the month</b> effective date must be received by the 15th of the month.
UNUM	<b>Five business days prior to the end of the month</b> : for the 1st of the month effective date. <b>15th of the month</b> available on approval basis only.
VSP	<b>VSP No deadline date</b> : for the 1st of the month effective date. 15th of the month not available.
